School Committee Meeting James R. Savage Educational Center Wednesday, November 19, 2014

A meeting of the Norwood School Committee was held on Wednesday, November 19, 2014. The meeting was called to order at 7:00 p.m.

**Administrators Present:** Mr. James Hayden, Superintendent of Schools; Dr. Alec Wyeth, Assistant Superintendent for Instruction, Curriculum and Assessment; and Ms. Ann Marie Ellis, Director of Finance and Operations.

**Minutes:** Mr. Gormley made a motion to approve the minutes of November 5, 2014, which was seconded by Mrs. Rau-Rogers. The Committee voted in favor 4-0.

Warrants: Chairman Badger informed that there were warrants to be signed.

**Appearances:** Student Representatives - Aloonee Adhikari, Saloonee Adhikari, Hannah Doherty, Viktorija Barone, Elizabeth Wagner: The Student Representatives updated the School Committee regarding the 4 A's at Norwood High School. (Academics, Activities, Arts and Athletics).

Mr. Hayden shared, with the Student Representative, an award received by the College Board that Norwood High School has received for outstanding academics. The Students were going to take the award back to the High School to give to Mr. Usevich.

Mrs. Rau-Rogers made a motion to move *New Business – FY16 Capital Outlay Projects* up in the agenda, which was seconded by Mr. Gormley. The Committee voted in favor 4-0.

<u>FY16 Budget Timeline Progress Report:</u> Mr. Hayden updated the Committee with regard to the FY16 Budget Timeline. Mr. Hayden said he will be meeting with Department Heads this week and he will have more information at the next meeting.

**Old Business:** <u>Union #50 Contract:</u> Mr. Hayden said this contract has been ratified. There will be a 2.5% increase for this school year and another 2.5% for next school year.

Mr. Gormley made a motion to approve this memorandum of agreement, which was seconded by Mrs. Rau-Rogers. The Committee voted in favor 4-0-1. (Mr. Montesano was not present).

<u>Committee of 21 Meeting (November 12, 2014) update:</u> Mr. Badger updated the Committee regarding the last meeting. The areas the Committee of 21 will be reviewing will be Special Education, Information Technology, facilities and revenue.

They have chosen 6 benchmark towns to compare Norwood with. These towns are: Dedham, Stoughton, Walpole, Milford, Canton and Burlington.

Acceptance of Four Donations: Mr. Hayden informed that in honor of the Norwood Bank's 125<sup>th</sup> Anniversary, the employees of the Bank have been authorized to donate \$125.0 to the charities of their choice. One employee chose the Prescott Elementary School as their donation choice.

Mrs. Rau-Rogers made a motion to approve this generous donation, which was seconded by Mr. Gormley. The Committee voted in favor 4-0.

Mr. Hayden recommended accepting a donation of \$143.25 from Bill McKinney of Marathon Physical Therapy & Sports Medicine for the Norwood High Track and Field Program.

Mrs. Rau-Rogers made a motion to approve this generous donation, which was seconded by Mr. Gormley. The Committee voted in favor 4-0.

Mr. Hayden recommended accepting a donation of \$1,500.00 from Eastern Massachusetts Surgery Center, LLC, for Norwood High School's Athletic Program.

Mrs. Rau-Rogers made a motion to approve this generous donation, which was seconded by Mr. Gormley. The Committee voted in favor 4-0.

Mr. Hayden recommended accepting a donation from Mylan Specialty of 2 Epi-pens and 2 Epi-pen, Jr.'s for each school in the district valued at \$1,500.00
